## 1. RECIPES

1.1. The regatta will be held in accordance with the 'rules' defined in the World Sailing Racing Rules.

1.2. Appendix R Rule, Special Procedures for Rule 42, will apply.

1.3. Appendix T RRS, Arbitration, will apply.

1.4. The PZZ Regulations "Rules for the organization of PZZ sailing regattas" apply.

1.5. In the rules governing this regatta:

[DP] means a rule for the breach of which the penalty is specified in the Introduction to the Rules of Procedure - Note. [NP] means rules that do not give rise to a protest or request for redress by a boat. This changes rule 60.1.

## 2. [DP] [NP] ADVERTISING

Yachts may be required to wear bow numbers and advertisements provided by the organizer.

## 3. CONDITIONS OF PARTICIPATION, APPLICATIONS

3.1. The regatta is open to boats of the classes defined in NoR 4.1.

3.2. Applications should be made using the on-line form available at [www.upwind24.pl](http://www.upwind24.pl)

3.3. The World Sailing Eligibility Code applies to all competitors.

3.4. Final applications should be made at the regatta office located in the club building at the CUKROWNIA Żnin marina within the time limit specified in point 6.1.

3.5. Competitors must have the following documents which may be required during the entry procedure at the race venue:

- proof of payment of the regatta entry fee,
- third party liability insurance for a minimum guarantee sum of EUR 1,500,000,
- consent of the parent / legal guardian to take part in the competition (for underage competitors),
- yacht certificate,
- current medical examination, in the case of competitors under 23 years of age,
- up-to-date medical examination or a signed health declaration for competitors over 23 years of age,
- sports license of a PZZ competitor,
- PZZ license for individual advertising (if applicable),

#### 4. ENTRY FEE

4.1. The entry fee to the regatta is:

4.2. Competitors who do not complete the application procedure within the above deadline (the date of application is decisive at [www.upwind24.pl](http://www.upwind24.pl)), are subject to an entry fee increased by 50%.

4.3. The regatta entry fee will not be refunded, unless the organizer cancels the regatta.

#### 5. FORMAT

If more than 60 yachts are entered in a given class, the organizer may divide the fleet. The classes to be divided will sail in the qualifying and final series.

#### 6. PROGRAM

6.1. Entry and racing program:

6.2. No warning signal will be given after 3.30pm on the last day of the regatta for which races are scheduled.

#### 7. EQUIPMENT INSPECTION

7.1. All boats must be ready for equipment inspection by 08:00 on the first race day.

7.2. Equipment inspection may also be performed at any time during the regatta.

## 9. RACE PLACE

9.1. The venue for the organization of the regatta will be the Marina in the CUKROWNIA Żnin hotel complex.

9.2. The races will be held in the waters of Lake Duży Żnińskie.

## 10. ROUTES

The routes will be specified in the Sailing Instructions.

## 11. PENALTY SYSTEM

11.1. In addition to rules marked [DP], the Sailing Manual may contain standard penalties that will be imposed by the race committee without a hearing. This changes Rule 63.1 and A5.

## 12. SCORING

12.1. The regatta will be considered valid after minimum 3 races have been held.

12.2. Scoring by age category and by competition (if applicable) will be calculated on the basis of the final performance of the fleet.

12.3. Where fewer than 3 races have been held, all a boat's performance in the series is counted towards her final score. If 3 or more races are played, the boat's one worst result will be rejected.

## 13. BOATS OF SUPPORTING PERSONS

13.1. All boats of the supporting persons participating in the regatta require accreditation of the organizer of the regatta during the registration procedure

13.2. All boats of supporters must have civil liability insurance for a minimum guarantee amount of EUR 500,000, which must be presented during registration.

## 14. [NP] [DP] PARKING SPACES

14.1. All yachts and equipment are required to be stationed in places specified by the Organizer.

14.2. The entry fee covers the costs of the yachts' parking on the days for which the races are planned and the entries. When the stay is longer than these dates, the yacht may be charged an additional fee.

## 15. [DP] RADIO COMMUNICATION

Race yachts may not use radio transmissions, text messages, mobile phones and communication devices other than those provided by the Organizer.

## 16. AWARDS

The best 3 yachts in each class will be awarded. The organizer may change the number of prizes if fewer than 10 yachts are entered in a given class.

## 17. IMAGE RIGHTS

17.1. By entering the regatta, the competitor agrees to:

- a) free use of their image by the Organizers and sponsors during photos, videos and other reproductions during the regatta and in all materials related to the regatta,
- b) processing of personal data contained in the regatta application for the purposes of the competition, by the personal data administrator - Polski Związek Żeglarski with its seat in Warsaw (03-901), al. Fr. J. Poniatowskiego 1, has been instructed that the provision of data is voluntary, but necessary to participate in the regatta, and that he / she has the right to access and correct his / her data,
- c) placing the data (1) in a publicly available list: race results, start lists (1) The consent concerns the following data: - name (s) and surname, - number and expiry date of the ID / license, - e-mail address, - date of birth .

17.2. [DP] [NP] Competitors may be required to be interviewed during the regatta.

## 18. DISCLAIMER OF LIABILITY

All competitors take part in the regatta at their own risk. See rule 3 'Decision to race'. The organizer accepts no responsibility for any damage, injury or death sustained in connection with participation in the regatta, whether during, before or after the event.
