## 1. PROVISIONS

1.1. The regatta will be held in accordance with the 'rules' as defined in the World Sailing Racing Rules.

1.2. Appendix P of the PRZ, Special Procedures for Regulation 42, will apply.

1.3. The "Rules of Organization of Sailing Regattas of the Polish Association" shall apply.

1.4. In the regulations for this regatta:

[DP] means a regulation for the violation of which the penalty is specified in the Introduction of the RG - Annotation. [NP] means a regulation that does not constitute a basis for a protest or request for redress brought by a yacht. This modifies rule 60.1.

## 2. [DP][NP] ADVERTISING

Yachts may be required to wear bow numbers and advertisements provided by the organizer.

## 3. TERMS OF PARTICIPATION, APPLICATIONS

3.1. The regatta is open to yachts of the classes specified in ZoR 4.1.

3.2. The application should be made via the upwind24 platform ([Information - REGATES CLASS OF POLAND PUCHAR IN FINN CLASS | Upwind24](#)).

3.3. The World Sailing Eligibility Code applies to all competitors.

3.4. Final regatta entries as well as fees can be made at the regatta office located in a container marked with a sign "Regatta Office" at the club building. The regatta office will be open from 17:05 at 09:00 until the end of the regatta.

3.5. Competitors must have the following documents that MAY be required during the entry procedure at the regatta venue:

- a) Proof of registration fee payment for the regatta,
- b) Public liability insurance with a minimum coverage of €1,500,000,
- c) consent of a parent/legal guardian to participate in the competition (applies to underage competitors),
- d) yacht certificate,
- e) A current medical examination, in the case of players under 23 years of age,
- f) A current medical examination or a signed statement of health, in the case of players over 23 years of age,
- g) An amateur or sports license of a PZŻ competitor,

h) PIF license for individual advertising (if applicable),

#### 4. REGISTRATION

4.1. The registration fees for the regatta are:

4.2. The entry fee should be paid to the account of Jachtklub PTTK No.: 75 8448 0004 0020 2459 2056 0003 in the title writing: Name Surname Goczałkowice 2025 Regatta - (class, e.g. finn sail number POLxxx), or in cash in the Regatta Office. The entry fee depends on the date of registration on the upwind24.pl platform.

4.3. Competitors who fail to complete the registration procedure by 11.05.2025 (inclusive) are subject to an increased entry fee.

4.4. Regatta entry fees will not be refunded unless the organizer cancels the regatta.

#### 5. FORMAT

If more than 60 boats are entered in a class, the organizer may divide the fleet. Classes that are divided will sail in the elimination and final series.

#### 6. PROGRAM

6.1. Entry and race program:

6.2. No warning signal will be given after 1:30 p.m. on the last day of the regatta on which racing is scheduled.

#### 7. EQUIPMENT INSPECTION

7.1. All yachts must be ready for equipment inspection from 10:00 am on the first day on which racing is scheduled.

7.2. Equipment inspection can also be done at any time during the regatta.

## 8. SAILING INSTRUCTIONS

Sailing instructions will be available on the official notice board located on the regatta office container.

## 9. PLACE OF REGATES

9.1. The place of organization of the regatta will be the marina of Jacht Club PTTK Pszczyna Address: 5 Dębowa Street, Wisła Wielka .

9.2. The races will be held on the waters of Lake Goczałkowice.

## 10. TRACKS

10.1. Routes will be specified in the Sailing Instructions.

## 11. PUNISHMENT SYSTEM

11.1. In addition to the rules marked [DP], the Sailing Instructions may include standard penalties imposed by the race committee without consideration. This amends RG 63.1 and A5.

## 12. POINT

12.1. The regatta will be considered valid after a minimum of 1 race has been played.

12.2. Scoring for each age category and competition (if applicable) will be calculated based on the final results of the respective fleet.

12.3. In the case of 3 or fewer races, all the results of a yacht in a series of races are counted for its final score.

## 13. BOATS OF SUPPORT PERSONS

13.1. All boats of support persons participating in the regatta require accreditation from the regatta organizer during the entry procedure

13.2. All supporters' boats must have third-party liability insurance with a minimum coverage of EUR 500,000, which must be presented at registration.

## 14. [NP][DP] PARKING SPACES

14.1. All yachts and equipment are required to be stationed at locations specified by the Organizer.

14.2. The entry fee covers the cost of berthing yachts on the days for which racing and entries are scheduled. When the berthing extends beyond these dates, the yacht may be charged an additional fee

## 15. [DP] RADIO COMMUNICATION

Yachts in the race are not allowed to use radio transmissions, text messages, cell phones and devices enabling communication, other than those provided by the Organizer.

## 16. AWARDS

The best 3 yachts in each class will be awarded prizes. The organizer may change the number of prizes if fewer than 10 yachts are entered in a class.

## 17. IMAGE RIGHTS

17.1. By entering the regatta, the competitor agrees to:

- a) free use of his image by the Organizers and sponsors in photographs, films and other reproductions during the regatta and in all materials related to the regatta,
- b) processing of personal data contained in the regatta application for the purpose of carrying out the competition, by the administrator of the personal data - Polish Sailing Association, based in Warsaw (03-901), al. ks. J. Poniatowskiego 1, has been instructed that providing the data is voluntary, but necessary to participate in the regatta, and that he/she has the right to access the contents of his/her data and correct them,
- c) placement of data (1) in a publicly available list: regatta results, start lists (1) Consent applies to the following data: - name and surname, - ID/license number and expiration date, - e-mail address, - date of birth.

17.2. [DP][NP] Competitors may be required to give interviews during the regatta.

## 18. DISCLAIMER

All competitors participate in the regatta at their own risk. See rule 3 'Decision participate in the race'. The organizer assumes no responsibility for any damage, injury or death sustained in connection with participation in the regatta either during, before or after the regatta.

## 19. Accommodation information
